

GENERAL DESCRIPTION

The successful candidate will perform the responsibilities of corporate counsel for Korea Floating Wind Power ("KFW"), report to the head of legal and the project director, and be based in Ulsan.

In-house counsel duties include, but is not limited to, the provision of advice in all areas of the organization's operations and legal matters, and the role will require the successful candidate to pay particular attention to the needs arising from Business Development, Procurement, Pertinent Regulations, and Dispute Resolution.

Occasionally, he or she may also be tasked with engaging fishermen and/or local residents for discussions and/or negotiations regarding matters that require investigations, settlement agreements, alternative resolution of disputes etc.

MAIN ACCOUNTABILITIES

- Provide legal advice and support, review contracts, and manage legal matters for other
 units including, but not limited to, business development and procurement with respect
 to existing offshore wind projects and new business opportunities.
- Review, draft, and negotiate MOUs and ancillary agreements such as confidentiality agreements, assignment agreements, and termination agreements.
- Draft, negotiate, and finalize commercial contracts including without limitation, joint
 development agreements, shareholders agreement, sale and purchase agreement,
 engineering service agreements, power purchase agreements, turbine supply
 agreements, EPC agreements, construction agreements, interconnection agreements,
 operation and maintenance agreements and consulting services agreements.
- Provide legal advice on permitting as well as working with other experts to obtain permits, consents, and studies required, or necessary, for the development and/or construction of the project.
- Provide legal advice on regulatory frames such as HSE and SAPA regulations, compliance with anti-corruption rules, fair trade laws etc.
- Draft legal documents and manage necessary corporate governance work including preparation of resolutions and other documents if necessary.
- Coordinate efforts with the legal and business teams regarding corporate and project requirements to ensure maximum value and appropriate risk management for KFW, KFW's affiliate East Blue Power, and KFW's shareholders.
- Identify critical project risk issues and communicate those risks to the appropriate members of the legal team or supervisor for resolution and management.
- Efficiently manage outside counsel with an eye toward minimizing expenses.
- Other tasks including, but not limited to, occasional summarization, registration, and translation, as assigned.
